### Terms and conditions for using the AbenteuerPark Potsdam of the Tree Event GmbH

#### 1. Scope and inclusion

1.1. These general terms and conditions for using the AbenteuerPark Potsdam of the Tree Event GmbH (hereinafter referred to as GTC) apply exclusively. We do not approve terms of visitors of the Park that either conflict with our general terms and conditions or deviate from them, unless we have agreed explicitly in written form.

1.2. The present GTC are a constituent of the contract that is being concluded either by expressed agreement or by the fact that they are displayed in clear view at the place where the contract is being concluded. Every visitor of the AbenteuerPark Potsdam needs to have acknowledged, understood and agreed to the GTC before entering the Park. In case there are questions regarding the GTC, the visitor needs to approach the staff at the ticket office before using the AbenteuerPark.

1.3. In case minors undertake activities in the Park either the parent, legal guardian or a person to whom the responsibility and the authority has been delegated to needs to have acknowledged the GTC and explained them to the minors before they are allowed to undertake activities in the Park. It is not possible for minors to undertake activities in the Park without consent of either the parent, legal guardian or the person who has the responsibility and the authority. Forms for parents or teachers need to be signed.

#### 2. Precautions

You need to be aware that there is a potential risk of injury when undertaking activities in the AbenteuerPark. While undertaking activities in the Park, the visitor needs to be particularly attentive and careful. Regarding our liability we refer to number 7 of these GTC.

#### 3. Requirements for use

3.1. Visitors must be at least 110 cm tall and not suffering from a medical condition or a psychological or physical impairment that could constitute a risk to either their own or other visitors' safety.

3.2. Children up to the age of 11 must be accompanied by an adult when they are climbing. The individual courses are accessible only if the requirements for use of the specific course (height and age) are satisfied.

3.3. Visitors who are under the influence of alcohol, drugs, medication or any other intoxicants are not allowed to undertake activities in the AbenteuerPark Potsdam.

#### 4. Regulations regarding behavior, safety and use

4.1. For the visitors' own good it is not permitted to carry items such as pieces of jewelry, cell phones, cameras, telescopes and so forth while climbing in the Park. Long hair must be tied back with a hair tie and secured underneath the helmet, as otherwise rope pulleys may cause injuries.

4.2. Before entering the Park every visitor (also when visiting repeatedly) needs to participate in the entire practical and theoretical safety demonstration.

4.3. Before climbing on to the start platform the so-called Expoglider-Shuttle needs to be attached to the first profile at the start of the ascent. The steel cable winches must be used exactly

according to the organizers' / Park Rangers' / trainers' instructions. In case of doubt, a Park Ranger must be summoned immediately.

4.4. The hired equipment may only be used as directed. It must not be taken off or passed on.

4.5. No more than one person may step on to elements at the same time. No more than 2 people may be located on the small platforms at the same time. On the low level of the large main platform a maximum of 10 people and on the high level of the large main platform a maximum of 6 people are permitted at the same time. Furthermore no more than 3 people may be on the ascent net at the same time.

4.6. When using the Park all regulations regarding behavior, safety and use as well as all organizers' / Park Ranger's / trainer's instructions and decisions are binding and need to be followed immediately. If a visitor does not fulfill these regulations regarding behavior, safety and use, further use might be prohibited and moreover he/she might be ordered out of the area. In that case, no refund can be claimed. In case any requirements of number 3 of the GTC are not being fulfilled we proceed equally.

#### 5. Acts of nature beyond our control

We reserve the right to close the entire or part of the AbenteuerPark Potsdam at any time for reasons of safety (e.g. in the case of fire, storm, thunderstorm etc.). If the park needs to be closed for reasons beyond our control and you have already started the course, you will not be entitled to any refund.

#### 6. Equipment

6.1. The hired equipment may be used for intended use only. On no account it may be removed from the area. The equipment must be returned 2 hours after the safety introduction at the latest.

6.2. In case of loss or non-accidental damage of the equipment, the visitor must indemnify the Park for the damage. In case of late return the visitor needs to pay a sum of EUR 5.00 per half an hour or part thereof.

#### 7. Liability

7.1. Within the framework of existing legal requirements we are liable for injuries to life, body and health. For any other harm we are reliable only in case of intent or gross negligence or in case of intent or gross negligence by people who are entrusted by us.

7.2. In case of infringement or violations against instructions or claims for safety by the organizer/ Park Rangers/ trainers the Tree Event GmbH is not liable for resulting damages.

#### 8. Prices

8.1. The prices valid for undertaking activities in the Park are the ones displayed by us at the timing of signing this contract.

8.2. In case the regular period of use of 2 hours is exceeded, the visitor must pay a sum of EUR 5.00 per half an hour or part thereof.

#### 9. Photo and videography

9.1. The Tree Event GmbH would like to point out to visitors that video footage is being made of the whole area in order to ensure safety.

9.2. Photography and (camera-) shooting (other than for private purposes only) is prohibited on the whole area of the Tree Event GmbH. In case of infringement we reserve the right to claim for damages.
